

The form below allows the user to input information directly using a computer keyboard. To begin:

- 1) Select the date using the drop down date selection.
- 2) Press Tab to move to the next item.
- 3) Select if this is a New application or Renewal.
  - A) Select New if you have not paid dues to the WOTFA within the past 3 years
  - B) Select Renew if you have paid dues within the past 3 years.

- 4) Press Tab to move to the next item.
- 5) Enter your mailing address, city, State, Zip Code and County in which you live. The county will determine which District you are affiliated with.
- 6) Enter your home phone number (optional) and your cell phone number (optional).
- 7) Enter the First and Last name of the person that will receive the Newsletter. The newsletter is not optional. Each household will be required to receive a newsletter.
- 8) Enter additional household members that are also joining the Washington Old Time Fiddlers.
- 9) Note the Total Dues at the bottom of the list. The form will calculate your dues based on the entries that you make.
- 10) You can not save the completed form to your computer. Use the print button at the top of this form to print the form and then mail it, along with your check or money order to the address listed.
